

INSTA-SET LCD ALARM CLOCK



Please read this before operating your clock

Battery Installation

- * The battery compartment is located on the bottom of the clock. Remove the battery cover and insert two "AAA" batteries according to the polarity indication inside the battery compartment. Replace the battery cover. (Batteries not included)
- * After inserting batteries, the clock will automatically indicate the AM/PM Time, Year, Date & Month. The default Time Zone is Pacific Standard Time (PST)

Setting The Time Zone

- * Press & hold the **Time Zone** button one second to activate time zone setting. The time zone digits will flash indicating it needs to be set. Press**Time Zone** button to set the desired time zone.
- * Press & hold the **Time Zone** button one second to return to normal time display mode, or after 10 seconds it will automatically return to normal time display mode.

Setting The Time

- * Press & hold the **MODE** button one second to activate time setting.
- * Press the HOUR\MONTH\YEAR button to set the correct hour. The PM indicator will light when the hour is advanced into the PM time.
- * Press the MIN\DATE button to set the correct minute.
- * Press & hold the **MODE** button one second to return to normal time display mode, or after 10 seconds it will automatically return to normal time display mode.

Setting The Calendar

- * After setting the time, press the MODE button one time. The Year digits will flash indicating it needs to be set. Example:Digit16 represent year 2016. Press HOUR\MONTH\YEAR button to set the correct Year.
- * Press the MODE button once again, the Month, Date digits will flash indicating it needs to be set.
- * Press the HOUR\MONTH\YEAR button to set the correct Month.
- * Press the **MIN\DATE** button to set the correct Date.

Setting The Daylight Saving Time (DST)

- * Slide the **ON**/ **OFF** DST switch to the **ON** position. The **DST** indicator will light up.
- * Slide the ON/ OFF DST switch to the Off position. The DST indicator will no longer be visible.
- * Do not turn the DST switch to **Off** unless you live in an area which does not observe the Daylight Savings time change.
- * DST starts: Second Sunday in March at 2am. Example: 2am to 3am (+1 hour)
- * DST ends: First Sunday in November at 2am. Example: 2am to 1am (-1hour)

Setting The Alarm Time

- * Hold down the ALARM button and then press HOUR\MONTH\YEAR button to set the correct hour. The PM indicator will light when the hour is advanced into the PM time.
- * Hold down the **ALARM** button and then press **MIN\DATE** button to set the correct minute. The PM indicator will light when the hour is advanced into the PM time.
- * Release the ALARM button when the correct alarm time is shown on the display.

Using The Alarm

- * Slide the ON/ OFF alarm switch to the ON position. The alarm indicator will light up.
- * Slide the **ON/ OFF** alarm switch to the **OFF** position to deactivate the alarm.

Using The Snooze

* Press the **SN00ZE** button when the alarm sounds and the alarm will sound again in 5 minutes. * The snooze function can be repeated many times.

Using The Backlight

* Press the **SN00ZE** button to activate the display backlight . The backlight will stay on for 5 seconds each time it is pressed.

Battery Warning

Clean the battery contacts and also those of the device prior to battery installation. Follow the polarity (+) and (-) when inserting battery.
